# Missionary Calling


## Personal History

My burden for the people of Hawaii began in my teens and led me to most recently serve as a church planting missionary to Maui from April 2017 to September 2025. While that chapter has now closed, God has opened a new door: Missionary Chaplain to the growing homeless communities across Maui.

In September 2025, I met with the Executive Director of the Maui Rescue Mission. We spoke about the mission's aim to guide individuals towards a new life in Christ and their struggle to meet this aim due to staff and volunteers being kept busy providing material aid.

To fill this vital need, we agreed to pursue my endorsement as a Missionary Chaplain to the Homeless on Maui by their organization.

After much prayer and counsel, I am confident that this missionary work is one that God has equipped me for and one that I am eager to pursue.



# Endorsing Organization



## Maui Rescue Mission

Established in 2017, Maui Rescue Mission operates as a completely mobile resource center for anyone struggling with homelessness on Maui.

Their resource center trailer is stationed at various locations throughout the week, offering mobile laundry services, a private hot shower, personal hygiene items, clean clothes, and connections to other resources.

The mission understands that without hope and basic human needs being met, life change for those who are homeless is nearly impossible. Their continued aim is to build trust, facilitate healing, and guide individuals towards a new life in Christ.

# Why This Mission Work?

## A Growing Mission Field

In September 2025, the Maui Rescue Mission shared that outreach attendance had increased by 40% in the past year. This escalating crisis highlights a spiritual need that is far outpacing current resources.

- **The Need:** At its current size, the Mission's dedicated staff and volunteers are often kept busy providing essential material aid, such as hot showers and laundry services. As a result, little time is left for meaningful connection directed toward leading people toward Christ.
- **The Solution:** As homeless communities on Maui continue to grow, there is a clear need for Spirit-filled ministers who can dedicate their lives to building genuine, trusting relationships in these communities; ministers that serve the homeless like Christ and have tact in lovingly pointing people toward a genuine relationship with Jesus.



# Endorsement Structure

## Why Endorsement?

Maui Rescue Mission has an established reputation within the homeless communities, county government, and various community agencies across Maui. Having their endorsement as a Missionary Chaplain to the homeless will provide me instant access and credibility to serve as a minister and missionary to the many homeless on Maui.

Crucially, I will not be an employee or salaried staff of the Mission, but rather a Missionary Chaplain that they endorse. This structure will allow me to have credibility with those I seek to serve, while also giving me the freedom to minister outside of Maui Rescue Mission's sphere as other opportunities arise.



# Missionary Roles

## Primary Responsibilities

Under endorsement of the Mission, my roles as a Missionary Chaplain will focus on dedicating myself to the spiritual needs of the growing homeless communities on Maui while working hand-in-hand with the Executive Director to establish procedures and best practices. My duties will include the following:

- **Ministerial Presence:** Becoming a constant chaplain presence at the Mission's weekly outreaches.
- **Chaplain/Crisis Care:** Conducting hospital visits, performing memorial services, and remaining on-call with the Mission for various spiritual and crisis needs.
- **Administrative & Development:** Collaborating with the Mission to define and document the new Chaplaincy procedures and pursuing relevant professional certifications.



# Missionary Goals

## Measurable Objectives (2026)

The success of 2026 will be measured by the following objectives:

- **Establishing a Weekly Spiritual Outreach:** Launching a weekly gathering designed to foster community, belonging, and Gospel hope through worship, prayer, Bible study, and a shared meal.
- **Spiritual Care:** Aiming to respond to requested chaplain care (hospital visits, counseling, etc.) within 24–48 hour.
- **Professional Growth:** Pursuing the completion of one relevant chaplaincy certification or training.
- **Consistent Partner Raising:** Reaching out to 20 potential partners weekly to share this vision and ask for their prayerful consideration of becoming a investment partner. Doing so bivocationally in order to provide for my family while pursuing investment partners to eventually do this work full-time.



# Missionary Impact



## Meet Chuck

The need for a dedicated Missionary Chaplain to the homeless can be clearly seen through the story of a man I know named Chuck.

I met Chuck while attending one of Maui Rescue Mission's outreaches during the spring of 2025. While I don't recall how our conversation began, I will never forget the hours we spent talking that day, during and after the outreach.

During our conversation, Chuck shared a vulnerable and powerful testimony: he had recently attempted to take his life but survived. As we talked, he shared something incredibly moving: "I believe there is a God, and I think He kept me alive for a reason." The problem was, he confessed, he didn't know who that God was.

With an open heart, Chuck allowed me to open the Gospel of John and explain that Jesus is God, according to John 1. As he listened, I could tell he had never heard the foundational truth of Jesus being God—the very truth that provides purpose and meaning to life. He was completely soaking up everything I shared and showed him from the Bible.

While Chuck has yet to profess faith in Christ (to my knowledge), his story perfectly illustrates the need for a consistent, Spirit-filled minister to the homeless. My desire is to dedicate the time necessary to move beyond just immediate needs and make an eternal difference in the lives of those who are often marginalized and unwanted on Maui.

# Investment Structure

## Missionary Agency

In order to dedicate my time as an endorsed Missionary Chaplain to the Homeless, I am seeking financial partners who will invest a portion of what God has given them toward this missionary work.

Such an investment can be given and will be handled by my missionary agency, Central Missionary Clearinghouse (CMC).

- **Who is CMC?** CMC is a well-established 501(c)3 non-profit organization that specializes in serving missionaries by processing funds for ministry endeavors.
- **Donor Benefit:** CMC receives gifts from donors, issues tax-deductible receipts, and provides secure financial services to help missionaries properly manage funds.
- **Purpose:** Your monthly investment through CMC will provide the resources required so that I can remain on Maui and faithfully serve in this new capacity.



# Investment Goals

## Monthly Ministry Investment Goals

To serve as the Endorsed Missionary Chaplain full-time, I am pursuing committed partners to invest in the sustaining, long-term needs of this new role. To ensure the effectiveness and long-term stability of this mission work, I'm pursuing two monthly investment tiers (a breakdown of the long-term tier is available on pg. 21).

- **Immediate Monthly Investment Goal:** \$8,400 (secures my presence on Maui and covers foundational needs)
- **Long-term Monthly Investment Goal:** \$16,400 (enables maximum sustained effectiveness for long-term stability)
- **Purpose:** These investment tiers represent the resources needed to maintain a focused, healthy, and sustained chaplain presence both now and in the future on Maui.

Investment Type	Purpose	Suggested Gift
<b>Monthly Ministry Investment</b>	Maintaining a focused, healthy, and sustained chaplain presence.	\$75 to \$500 (or more) per month

Gift Levels	Investment Impact
<b>\$50</b>	Covers one month of WIFI, ensuring timely reporting to partners and critical coordination with the Maui Rescue Mission.
<b>\$100</b>	Provides about one-fourth of current health insurance cost, securing the well-being required for sustained mission service.
<b>\$750</b>	Funds half of my family's monthly food needs, ensuring the strength and focus to serve the homeless community every day.
<b>\$900</b>	Covers one-third of my current housing costs, securing the necessary residence and environment for planning, rest, and outreach.

# Online Investing

## Instructions

Use the steps listed below to set up your account and begin giving a one-time or recurring investment gift through Central Missionary Clearinghouse's giving platform "Click&Give."

1. Go to [myclickandgive.com/login.php](http://myclickandgive.com/login.php).
2. Click the "New Account" button.
3. Fill in the requested information and click "Create Account."
4. Log in to the email account you provided during the last step. Then activate your account by clicking the "Activate Now" link in the email you were sent.
5. Log into your "Click&Give" account using the email and password you chose. If the "Select Merchant" page appears, click the CMC logo.
6. On the top of your screen, click the "Give" button (It looks like a check & pen).
7. Click the "Search for account dropdown" and select "Brunk, Matt."
8. Type in the amount you want to give, click "Add to donation," and then click "Continue."
9. If your gift is for something specific, type that into the "memo" section (optional). Then select your payment method, fill in your account information, add a billing address, and then click "Continue."
10. Under "Make this gift recurring," click the "Set Up" button if you plan to make this a recurring gift. Otherwise click "Continue."
11. If you chose recurring, select a frequency ("monthly by date" is recommended). Then choose what day of the month you would like your donation to be taken out.
12. You will also need to choose a start date for future gifts along with an end date (these are no longer optional). For the end date, a day 10-20 years from now is recommended (you can still end your gift at anytime).
13. When the popup shows up, click "Ok."
14. Click "Continue," confirm your information, and then click "Give."

# Core Beliefs

## CONCERNING THE BIBLE

I believe that the Bible in its original writings — consisting of 66 books and divided by the Old and New Testament — is God's inspired (2 Ti 3:16), inerrant (Jhn 17:17; 1 Th 2:13; Heb 6:18), and infallible (Jhn 17:17; Psa 19:7) Word for mankind. It has by God's providence been kept pure in all ages (Mat 24:35; Isa 40:8). It is the final authority for all matters of faith and practice (2 Ti 3:16). I interpret the Bible according to its literal, grammatical-historical meaning, recognizing that while application may vary, there is only one true interpretation. It is the responsibility of every believer to diligently ascertain the true meaning of a given passage under the enlightenment of the Holy Spirit, recognizing that its proper interpretation is binding on all generations (Psa 119:160; Jhn 16:12-15; 1 Co 2:7-15; 2 Ti 2:15).

## CONCERNING THE TRIUNE GOD

I believe God is the Creator of all (Gen 1 & 2; Col 1:16; Jhn 1:3). He is spirit (Jhn 4:24) and eternally exists as three persons — Father, Son, and Holy Spirit — yet is one God (Gen 1:26; Deu 6:4; Mat 28:19). The three Persons are co-eternal in being, co-identical in nature, coequal in power and glory, and possess the same attributes, including being perfectly love, holy, and just (Deu 6:4; 32:4; Psa 90:2; Mat 28:19; 1 Pe 1:16; 1 Jhn 4:8). There is no other god besides Him (Isa 45:5).

I believe Jesus Christ is the eternal Son of God (Jhn 1; Mar 1:1). For mankind's salvation, He became flesh, conceived by the Holy Spirit and born of the virgin Mary, while retaining His full deity (Isa 7:14; Mat 1:25; Luk 1:26-35; Jhn 1:1, 3, 14, 18, 29; Phi 2:5-11; 1 Ti 3:16). He lived a sinless life, died, and physically rose again as God's acceptable propitiation for sin (Rom 5:6-15; 2 Co 5:21; 1 Jhn 2:2; 4:10). After His death and resurrection, He ascended into heaven where He now sits at God's right hand being our Great High Priest (Rom 8:34; Heb 7:25, 26; 9:24-28) and will one day visibly return to earth (Act 1:9-11).

I believe that the Holy Spirit is present in the world today convicting and convincing unbelievers of sin, righteousness, and judgment (Jhn 16:7-11). He lives in every believer from the moment of salvation as their Comforter and guide into all the Truth (Jhn 14:16-17; 16:7-13; 1 Co 2:12; 3:16; Eph 1:13-14). Believers are to live under His guidance daily (Gal 5:16, 18, 25; Eph 5:18). I believe that He administers spiritual gifts to believers and is sovereign in bestowing of all such gifts (1 Co 12:4-11).

# Core Beliefs

## CONCERNING HUMANITY, SIN, AND SALVATION

I believe God created mankind in His image (Gen 1:26, 27), first Adam, then Eve (Gen 2:7-25). Created sinless but with free will, mankind chose to disobey God, resulting in alienation from Him (Gen 2, 3; Isa 59:1, 2). Consequently, mankind inherited a sinful nature and is, of itself, unable to remedy its lost condition (Isa 53:6; Rom 3:23; 5:12; Eph 2:1-3).

I believe the wages of sin is death (Rom 6:23). Jesus' physical death on the cross is the only acceptable propitiation for our sins according to God (1 Co 15:1-4; 1 Jhn 2:2; 4:10). Such salvation is the gift of God and not a result of a person's good works or any human efforts (Eph 2:8-9; Gal 2:16; Tit 3:5). To be saved one must be born again (Jhn 1:12-13; 3:3). This new birth is a work of God's grace whereby believers become new creations in Christ (Tit 2:11; 2 Co 5:17). It is a change of heart wrought by the Holy Spirit through conviction of sin, to which the sinner responds in repentance toward God and faith in the Lord Jesus Christ (Jhn 16:8; Act 3:19; Eph 2:8-9; Rom 10:8-11).

I believe that because God gives eternal life and the Holy Spirit as a seal, those truly saved cannot lose their salvation (Jhn 3:16; Rom 6:23; 2 Co 1:22; 5:1-5; Eph 1:13, 14; 4:30). Salvation is secured and maintained by God's grace and power, not by human effort (Eph 2:8, 9). God, being one who cannot lie, secures our salvation as He promises in His Word (Jhn 3:16; 10:29; Rom 10:9, 13; Tit 1:2).

## CONCERNING ETERNITY

I believe mankind was created by God for eternal existence (Gen 2), resulting in two final destinies now: eternal separation from God because of sin or eternal life with Him through the salvation of Jesus Christ (Jhn 3:16, 36; 5:28-29; Rom 6:23).

The saved are immediately present with the Lord in conscious bliss upon death, awaiting the resurrection of life and glorification (Jhn 5:28-29; 2 Co 5:8; Phl 1:23; 3:21). The unsaved enter conscious punishment, awaiting the resurrection of condemnation and the Great White Throne Judgment, where they will be cast into the literal Lake of Fire to suffer everlasting physical and conscious torment, not annihilation (Mat 25:41-46; Luk 16:19-26; Jhn 5:28-29; 2 Th 1:6-9; Rev 20:11-15).

# Core Beliefs

## CONCERNING THE CHURCH AND ITS PRACTICE

I believe that the New Testament Church began with the calling out of the twelve apostles by Jesus Christ and was empowered on the day of Pentecost (Mat 16:16-18; Act 1, 2). It is the body and bride of Christ, of which Christ is the head (1 Co 12:27; Eph 5:23; Col 1:18). The church on earth exists as localized congregations composed of saved and baptized individuals, voluntarily united under Christ and His Word (Acts 2:41, 42; 9:31; 15:41; 16:5). The biblical offices of the church are Bishops/Elders/Pastors and Deacons (1 Ti 3:1-15). The office of pastor specifically, by the context of Scripture, is to be held only by naturally-born men who meet the qualifications of 1 Timothy 3 and Titus 1.

The local church is commanded to demonstrate love for all people, including those who engage in sin or opposition (Mat 5:44-48; Jhn 13:34-35; Rom 13:8-10). While God commands His church to abhor what is evil, believers must deal with those who oppose them gently, patiently, and humbly (Rom 12:9; 2 Ti 2:24-26). The church is to love and pray for any person engaged in sinful actions (Mat 5:44-48; Rom 12:9-10). Believers are strictly forbidden from taking revenge or seeking personal justice (Rom 12:17-21; 13:8-10; 2 Ti 2:24-26).

## CONCERNING EVANGELISM AND MISSIONS

I believe God instructs all believers to proclaim the Gospel wherever He leads and to whomever He leads, so that all may have the opportunity to call upon God for salvation through Jesus Christ (Mat 28:19-20; Mar 16:15; Luk 24:46-48; Act 1:8). As ambassadors of Christ, we must use all available means to go to all nations and not wait for them to come to us (Mat 28:19-20; 2 Co 5:20).

# Core Beliefs

## CONCERNING HUMAN SEXUALITY


I believe that God has commanded that no intimate sexual activity be engaged in outside of marriage (1 Co 7:1-9; Heb 13:4). I believe that the only Biblical marriage is the joining of one naturally-born man and one naturally-born woman for life (Gen 2:24; Mat 19:4-5).

I believe that any form of sexual immorality (including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, and use of pornography) is a sinful perversion of God's gift of sex (Lev 18:1-30; Rom 1:26-29; Eph 5:3; 1 Co 5:1; 6:9, 10; 1 Th 4:1-8).
